State Librarian**

Daria Bossman reported on a number of items:

- Gift for promotions: National Library week April 10-16, 2017
  - Lesta Turchen gave a gift of \$300 to be used towards promotion items for National Library Week.
- South Dakota Share-It update
  - 70 libraries participating
  - 30 slots still open
- Personnel Updates
  - New Hire, Alissa Adams
    - Replaces Joan Upell as School Library Technology Coordinator
  - Search Committee
    - Jane Healy's last day was Friday, September 23, 2016
    - Steven Buras is heading the search committee
      - 9 applicants
      - Meeting next week to set up interviews
- 2017 SDLA Library Legislative Day – February 16, 2017
  - Traditionally mid-January, has moved to mid-February
  - SD Library Board generally meets on this date
  - SDLA legislative lunch and Library Accreditation Certificates at the Rotunda
- South Dakota Library Certifications
  - 25 individual library certifications
    - From 23 libraries and 17 communities
  - 3 year certifications
  - Voluntary
    - Recognized at SDLA Conference
- 2016 Statistics
  - BTB numbers are increasing
    - Lose about 50 patrons/month through death
    - More contacts through institutions
  - Increase in electronic resources as more people know they are there and use them
  - 400% increase in State Publication views
  - Outreach has fewer staff; fewer site visits
- South Dakota Data Digest 2016
  - Easy to read and informative

- More and more states are now doing these/ SD leads the way
- OCLC Information
  - Plays a huge role in SD's connection with the world
  - Only 17 institutions (including SDSL) currently pay an annual fee to access
  - 50,000 ILL requests sent out of state by SD libraries last year
- IMLS planning grant opportunity
  - The North Dakota State Library, in partnership with the South Dakota State Library and Wyoming State Library is seeking a Laura Bush 21<sup>st</sup> Century Librarian Program planning grants for a workforce study
    - Bossman reported that due to a technicality, the application was thrown out, will try again next fall
  - We need to grow our own
